Hooker Super Competition Y-Pipe Assembly 93-97 Camaro / Firebird with LT1 Using Hooker Header #2231HKR

Thank you for making Hooker Headers your choice in high-performance exhaust systems. Extensive dyno/track testing has enabled Hooker to offer the most advanced design in exhaust systems. The installation, while not complex, will take a certain amount of time. However, the additional horsepower and improved performance will more than justify your efforts. Proper installation and maintenance will ensure a long life and maximum performance from your Hooker exhaust system.

BEFORE STARTING

Your vehicle must be raised a minimum of 36 inches. A floor hoist is ideal. If no hoist is available, we strongly urge the use of axle stands as a safety measure.

CAUTION! Your car should not be supported on a bumper jack. We recommend welding all pipe slip joints. If no welding equipment is available at the time of the installation, use the furnished clamps to secure the pipes, until they can be welded.

NOTE: This Y-Pipe is designed to fit with Hooker Header P/N 2231HKR ONLY!

NOTE: This Y-Pipe will bolt to Hooker Super Competition Cat-Back system P/N 16827HKR & 16825HKR.

INSTALLATION PROCEDURE – PLEASE READ CAREFULLY

1. Install Hooker Header P/N 2231HKR per instructions included with it.
2. Install Y-Pipe assembly to the headers with the gaskets.
3. Connect the exhaust system to the Y-Pipe.
4. Install the three (supplied) T-bolt clamps at the slip joints and tighten.
5. Re-install the under-driveshaft cross-member using the 1 inch diameter aluminum spacer and bolts.
6. Start and check for leaks.

When finished, give your vehicle a test drive, checking carefully for any new noises. After several days of driving, re-tighten all the bolts.
